BACKGROUND

- 1.1 The Joint Committee approved its Financial Regulations at its annual meeting in September 2010. Those Financial Regulations included arrangements for procuring goods and services. The Regulations state that the Head of Service can allow exceptions to these regulations if it is believed that the best interests of the PATROL Joint Committee would be served if the regulations were not applied.
- 1.2 A number of strategic suppliers were in place prior to the introduction of the Financial Regulations and some have been in place since the inception of the Joint Committee where reliance was placed upon the Lead Authority's approved suppliers.
- 1.3 The purpose of this report is to report on services which have been procured outside the framework of these regulations, to seek approval for the planned arrangements for reviewing these services.
